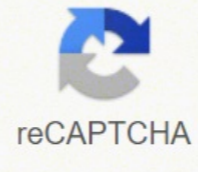

RTI services will be applicable to all departments/offices which have been provided with ICT infrastructure and connectivity for delivery of services under e-District Scheme. The States while identifying the services under the 5 core services should leverage the services identified and developed under the Implementation of State Portal, SSDG and Electronic Form project. Does the incorporation certificate apply to a one-person company too? It is a license for conducting business. Services from different departments are brought under one umbrella at any CSC. (iii) Revenue Court including services – including Case listing, Case adjournment, Stay orders, Final orders, Status of execution of orders: information, tracking, filing of miscellaneous applications. Affidavit for a Domicile Certificate: In order to obtain a domicile certificate, the applicant will have to make an Affidavit. The certificate gets processed within seven days from the date of application. It utilizes backend computerization to e-enable the delivery of services and ensures transparency and uniform application of rules. The domicile certificate once received is valid for a lifetime unless the holder changes his residence and moves to a different state. Age proof such as birth certificate, school certificate (10th admit card), etc. Two passport size photographs. Proof of identity such as an Aadhaar card, PAN card, etc. Self-declaration form. Duly filled the application form. Photocopies of all documents duly attested by a government official. In simple words, an applicant who is a permanent resident of a particular state or union territory and holding a valid proof of identity & residence can create the affidavit for domicile certificate. The affidavit for the domicile certificate must include the details listed below: Name, age and address of the applicant (deponent). Name of the father or name of the spouse and details (in the case where the applicant is a married woman and not being a permanent resident of the state in which she wants to claim domicile certificate). Read less In general, a domicile Certificate or a residence certificate is issued by a state government to prove that the person having the domicile certificate is a resident of that particular State or Union Territory as stated in the domicile certificate.
